## 2021-22 Federal Direct Student Loan Request

The U.S. Department of Education offers low-interest **Federal Direct subsidized** and **unsubsidized** loans to eligible students to help cover the cost of college. To receive either type of loan, you must be enrolled at least 1.5 units (half-time) at Pomona College **and have completed a FAFSA for the 2021-22 academic year**. Direct Loan funds are applied equally to fall and spring semester charges. For complete loan terms and conditions, please refer to the **Loan Agreement for a Subsidized/Unsubsidized Loan (MPN)** at **StudentAid.gov**.

### Interest Rates & Origination Fees:

- **Current Interest Rate: 3.73%** fixed for loans disbursed after July 01, 2021.
- **Current Loan Fee: 1.059%** of loan amount for loans disbursed before October 01, 2021.

### Direct Loan Annual Maximum Borrowing Limits for Dependent Students

**First Year Students:** \$5,500 (of which no more than \$3,500 may be subsidized)  
**Second Year Students:** \$6,500 (of which no more than \$4,500 may be subsidized)  
**Third and Fourth Year Students:** \$7,500 (of which no more than \$5,500 may be subsidized)

Your loan eligibility may be less than the borrowing limit if your total financial aid, including loans, exceeds your cost of attendance. Your loan request will be reviewed for subsidized eligibility. Subsidized loans are added to your financial aid first if you are eligible. Subsidized loan eligibility regulations may be found at **Studentaid.gov/sub-unsub**.

### Loan Request Steps for New Borrowers

To request a **2021-22 Federal Direct Student Loan**, complete the following steps:

1. Log into **StudentAid.gov** using your **FSA ID** and:
  - Complete **Direct Loan Entrance Counseling**
  - Complete the **Subsidized/Unsubsidized Loan MPN**
2. Submit this completed **Federal Direct Student Loan Request Form** to the Office of Financial Aid.
